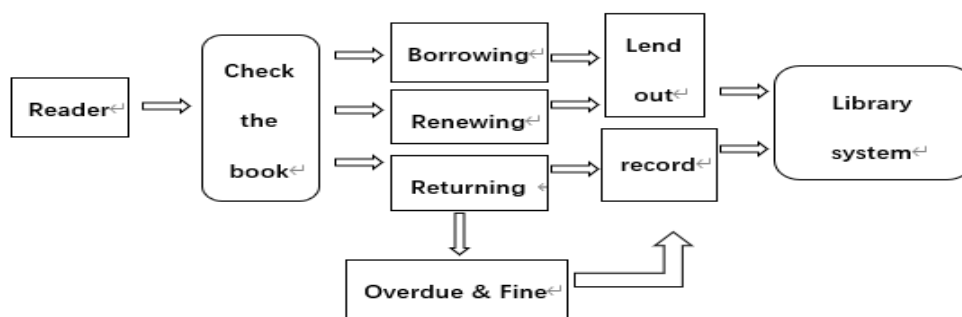

**Community Building and User Engagement**

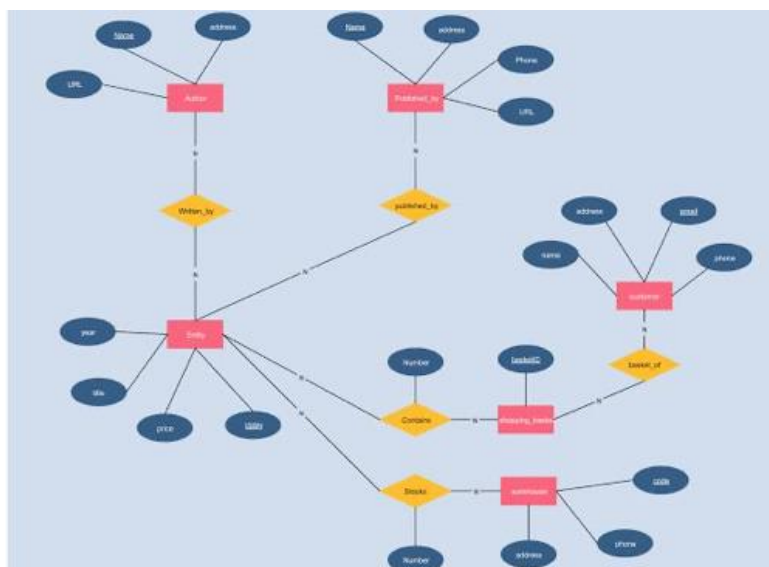

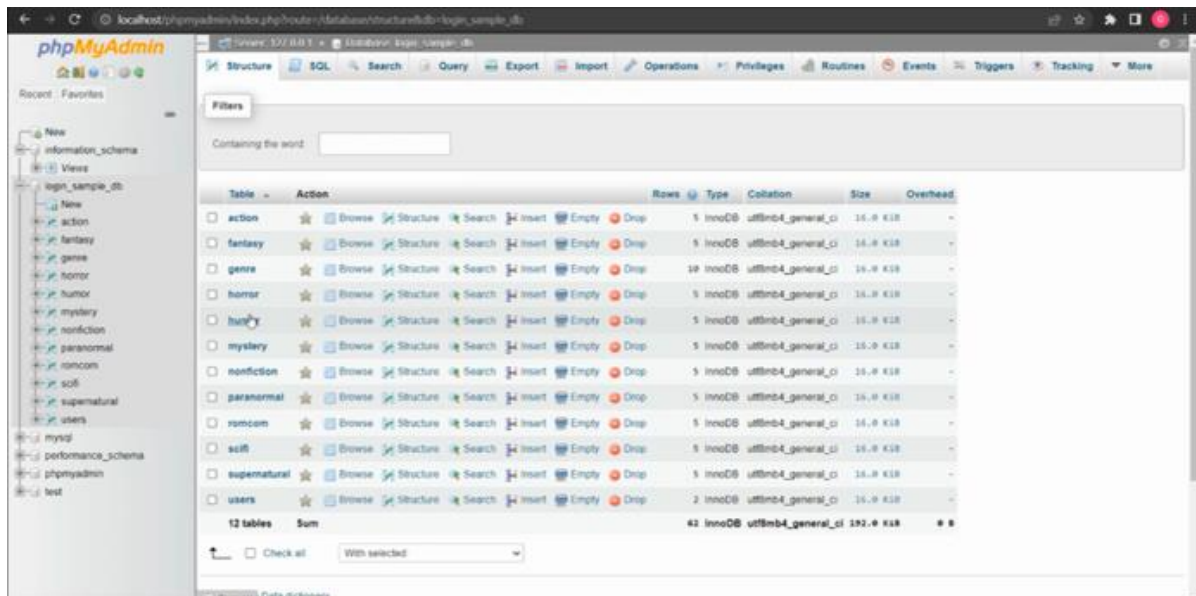


Fig 3. Database: Database of books [3]
