Researchers adopted only secondary data since this research comes under conceptual study i.e. Articles, Journal, Govt. Reports, Bulletins, newspaper etc.


## c) Research area:

Fixed deposit: Through the special Bal Kalyan Yojana, every orphan child will be given financial assistance every month out of a lump sum amount of 10 lakhs fixed for higher education, which he can use at the age of 18 to 23 years. For special child welfare scheme 10 lakh rupees will be paid from the Prime Minister Care.

Primary education under 10 years: children will be admitted as Day Scholar in the nearest central school or private school under the Bal Kalyan Yojna, the fee will be paid from the Prime Minister Care fund, if a child is granted in a private school, then his fees will also be paid. Provided as per norms will be done from Prime Minister Care fund. Along with this, the cost of school dress text book note book will also be raised from the Prime Minister Care fund.

Secondary and higher secondary education under 11-18 years: Children orphaned due to corona pandemic will be admitted to residential schools of central government like Kendriya Vidyalaya Navodaya School or military school. If the parent or grandparent's family takes care of the child, he/she will be admitted to the closest central school or any other school as day student.

Higher Education Facility: the child will be assisted in obtaining an education loan for professional courses, or higher education in the country as per the existing education loan norms. The interest on this loan will be paid by the pm-cares. As an alternative, scholarships equivalent to the tuition fees or the course fees for undergraduate/vocational courses as per the government norms will be provided to such norms will be provided to such children under central or state government schemes for children who are not eligible under the existing scholarship schemes; pm-cares will provide an equivalent scholarship. Pm-cares will provide an equal scholarship.

Medical Expenses: Under the Ayushman Bharat Scheme (PM-JAY) of the government of India, all orphan children will be provided health insurance of Rupees Five lakh and health insurance premium will be paid from the PM-Care Fund.
